OFFICE MEMORANDUM

SUBJECT: GRANT OF AD-HOC RELIEF ALLOWANCE-2025 TO ALL CIVIL SERVANTS OF SINDH GOVERNMENT.

The Government of Sindh Cabinet has been pleased to sanction an Ad-hoc Relief Allowance-2025 with effect from 1st July, 2025 to all Civil Servants of Sindh Government as well as contractual employees against civil posts in Basic Pay Scales on standard terms and conditions of contract appointment. The rate of Ad-hoc Relief Allowance-2025 is as under:

- i) BPS-01 to BPS-16 @ 12% of Running Basic Pay
- ii) BPS-17 to BPS-22 @ 10% of Running Basic Pay

2. The amount of Ad-hoc Relief Allowance-2025;

- i) will be subject to Income Tax;
- ii) will be admissible during leave and entire period of LPR except during Extra Ordinary Leave (EOL);
- iii) will not be treated as part of emoluments for the purpose of calculation of Pension / Gratuity and recovery of House Rent;
- iv) will not be admissible to the employees during the tenure of their posting / deputation abroad; and
- v) will be admissible to the employees on their repatriation from posting / deputation abroad at the rate and amount which would have been admissible to them had they not been posted abroad.

3. The term "Basic Pay" for the of Ad-hoc Relief Allowance-2025 will also include the amount of the Personal Pay granted on account of annual increments(s) beyond the maximum of the existing pay scales.




