




NOTIFICATION

No.FD/SO(Admin-I)/26(1)/2025 : With the approval of the Chief Minister Sindh, the Finance Department, Government of Sindh are pleased to notify the establishment of the **Public Financial Management Unit (PFMU)** in the Finance Department, Government of Sindh with hierarchical structure and functions:-



Functions of Public Financial Management (PFM) Unit:

- (i) Providing support to the Finance Department in developing and implementing new financial management policies and procedures.
- (ii) Reviewing existing financial management policies and procedures to bring improvement in public financial management for the provincial government.
- (iii) Facilitating & supporting capacity building team of Finance Department to manage financial resources effectively and efficiently.
- (iv) Providing necessary support in implementing various PFM related reform initiatives included in PFM Reform Strategy.
- (v) Improving Financial Reporting, Cash Management Function and Accountability.
- (vi) Ensuring adherence of relevant PFM laws and regulations while functioning/framing PFM Policy instruments for the provincial government.
- (vii) Facilitating the Finance Department in budget formulation, execution, monitoring and evaluation of annual budget of Government of Sindh.

- (viii) Supporting Finance Department in preparation of MTBF for line departments.
- (ix) Assisting Finance Department to address various issues especially budget variance.
- (x) Developing and maintaining a financial reporting system that provides accurate and timely information to management and stakeholders.
- (xi) Preparing regular financial reports and their analyses to support informed decision-making.
- (xii) Designing and delivering trainings to officers/officials on financial management.
- (xiii) Overseeing the implementation and management of the SAP system for financial accounting and human resource management.
- (xiv) Facilitating the seamless integrating SAP system with financial management processes.
- (xv) Any other assignment given by the high-ups.

3. The expenditure involved for establishment of Public Financial Management Unit will be met out from the budgetary allocation to be allocated under the head of account of "KQ2974-PFM Unit Karachi" for Public Financial Management Unit Finance Department.
